CONDITIONS OF ENTRY**

CONTESTANT MUST:

1. Be a resident of Knox or surrounding counties.
2. Winners of other Fairest of the Fair or Junior Fairest of the Fair contests in any given year are not eligible.
3. Fairest of the Fair Contestants must have reached her 16th birthday at the time of the contest but not her 21st birthday on or before Dec. 31, 2011. Not be or plan to be married or have or plan to have a child before Sept. 8, 2012.
4. Junior Fairest of the Fair contestants must be 13-15 years of age at the time of the contest. Not have or plan to have a child before Sept. 8, 2012.
5. Not have been found guilty of a felony.
6. Currently be and always have been of the female gender.
7. Wear a formal, floor length gown for contest. No exposed midriff and no cut outs.
8. Provide a 5 x 7 photograph (head and shoulders) with entry form. It is understood that this photograph will be used for Miss Photogenic judging and becomes property of the Fair and may be used for publicity.
9. Attend rehearsal on Thursday Sept. 8, 2011.
10. Be available as an official Fair representative fulfilling specific duties DAILY during the Fair, including events throughout the year.
